In compliance of the guidelines of Ministry of Environment and Forest (MoEF) Government of India's letter No.II-9/98-FC(pt) dated: 3<sup>rd</sup> August, 2009 on submission of evidence for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for Shot) on the forest land proposed to be diverted for non forest purposes read with MoEF's letter dated 5<sup>th</sup> February, 2013 wherein MoEF issued certain relaxation in respect of liner projects. It is certified that 4.47 Ha hectors of forest land proposed to be diverted in favour of M/s Sri Sai Rocks (name of user agency) for extraction of Black Granite i.e., for Mining, Road, Safety Zone and Dumping Area (purpose for diversion of forest land) in Compartment No.103 of Boyakonda RF of Punganur Mandal of Chittoor West Division falls within jurisdiction of Chandramakulapalle village (s) in Punganur Mandal.
