The Regional Empowered Committee (REC) in its meeting held on 17-18 June, 2021 at Integrated Regional Office, Chandigarh has approved the proposal and authorized Regional Officer, IRO Chandigarh as Chairman of the REC to accord Stage-I approval with standard conditions after receipt of the following information:-

- (i) The extent of area proposed for diversion in this proposal and in future proposals to be restricted to four places after decimal.
- (ii) Uniformity in the extent of area proposed for diversion to be made in the proposal from 8.23 ha to 8.2331 ha in this proposal.
- (iii) CA estimate to be revised from 8.23 ha to 8.2331 ha
- (iv) Revised KML file of CA site to be uploaded online.


