In this regard, the state government of Uttarakhand submitted that the governor, Uttarakhand was withdrawal the notification No. 869F/638 dated 17-10-1893 under Indian forest act 1878 as per state notification dated 28-09-2011 and hence was some construction activity has been done by user agency. In this regard, this office has already issued letter dated 08-01-2024 that such de-reservation is a violation of van (sanrakshan & sarvardhan) adhiniyam 1980. Comments from state government is required to be submitted.	अवगत कराना है कि वन एवं पर्यावरण अनुभाग-3 सं0 866/-3-2011/8(21)/2010 दिनांक 28.09.2011 द्वारा जारी अधिसूचना द्वारा अधिसूचना सं0 869/एफ/638 दिनांक 17.10.1893 को विखण्डित किया गया है, जिसके अनुसार जिलाधिकारी पिथौरागढ़ के आदेश सं0 395/सात-8/2017-18 दिनांक 29.11.2017 के क्रम में प्रस्तावक विभाग द्वारा अग्रेत्तर कार्यवाही की गयी है। उक्त आख्या इस कार्यालय के पत्रांक 7612/12-1 दिनांक 13.05.2024 द्वारा पूर्व में भी प्रेषित की गयी है, जो कि पुनः संलग्न कर प्रेषित की जा रही है।
