As regard justification for not insisting upon the compensatory afforestation area, I am to stated that as the proposed area is only 1.0 Ha. and is devoid of any tree coupled with the fact that fund for creation of safety zone plantation around the Mahal area and afforestation of 1.5 time safety zone area will be realised from the user agency. Hence, Compensatory Afforestation was not insisted which may kindly be considered.

In view of the above, you are requested to kindly grant the "In-Principal Approval" in respect of the proposal for diversion of 1.0 ha of forest land for operation of Modertoli Stone Mahal No.4 under Nagaon South Division in favour of Md. Farhan Uddin Hojai at your earliest convenience.
