In this regard, it is submitted that the matter has been got enquired through CF GHNP Shamshi and on the basis of his report the comments of the undersigned are as under:-

1. The distance of proposed site from the Wild Life Sanctuary Nargu is 1 Km & from its proposed Eco- sensitive Zone is 900 meters.
2. The distance from the Wild Life Sanctuary Nargu is less than 10 Km and if 5.00 MW Thaltukhod Stage-1 SHEP is constructed, there will be no direct impact/ disturbance to Flora and Fauna of Nargu Wild Life Sanctuary.
3. There is no specific Wild animal passage recorded in the above said areas and in view of the above that there is no requirement of Animal passage Plan for the construction of 5.00 MW Thaltukhod Stage-1 SHEP.
