Please refer to GoI office memo No. FC/HPB/09/82/2022 dated 09.08.2022 on the subject cited above.

Point wise reply of observation raised by GoI given is as under:-

1. User agency has informed that, no non forest land is available in city area of Distt. HQ Shimla as all Government land over which Government has proprietary rights, has been classified as forest land vide notification no. ft(a)- 1/52 dated 15th January 1952 issued by the Secretary to Chief Commissioner. Reply of user agency is enclosed herewith.
2. As per the user agency informed that in online portal part1, B-2.1, details of divisions' name of forest division is not editable as it was auto dropdown in Parivesh Web Portal. Shimla (Shimla) is known as Shimla (Rural) Forest Division. Online as well as the Shimla Forest Division.
3. There is no construction of any residential, institutional and commercial structure in this proposal.
4. User agency has reported that the proposed site is not that much hilly/ sloppy and it is less than 45°/35° during the time of construction, Brest wall will be constructed first to avoid soil erosion/landslide. This should be prior to cutting of the hills.
5. The approval of the competent authority is enclosed herewith.
6. Area in Non availability of Non Forest Land certificate was 0.2852 hectare duly issued by the Deputy Commissioner, District Shimla. Reply of user agency is enclosed herewith.
7. DFO Shimla has reported that, during the site inspection, it has been found that 58 trees are standing on the proposed area and he is requested the user agency to reduce the large No. of

trees/reduce the area. Thereafter the user agency has reduced the area. The revised Tatima as well as field book has already been submitted in proposal folders.

8. User agency has informed that there is no need to take approach road as the proposed site is along with existing road. In this regard, NOC from HPPWD has been obtained and the same is enclosed herewith.
9. NOC's from HPPWD, Fire dept. Jal Shakti vibhag and HPSED is enclosed herewith.
10. Necessary correction has been done in KML file.
11. User agency as submitted that the proposed site is not that much hilly/sloppy. During the time of construction, Brest wall be constructed first to avoid soil erosion/landslide.
12. Revised CA Scheme i.e 215 plants is prepared and uploaded online as well as enclosed herewith.
13. The CA land proposed is in UPF-583 Sohal, the copy of working plan is enclosed herewith.
14. Necessary correction has been done in online part-II.
