Sub: APFD – F(C) Act, 1980 – Proposal for diversion of forest land to an extent of 2.96 Ha in Compt.No.313 of G.A Bad South RF of Kurnool Division for grant of quarry lease for Road metal in favour of Sri G.Maddilety Reddy – Proposals returned – Resubmission of –Reg.

In continuation of this office reference 3rd cited, it is submitted that, in the reference 4th cited, the Conservator of Forests, Kurnool Circle, Kurnool had returned the proposals for diversion of forest land to an extent of 2.96 ha in Compt.No.313 of G.A Bad South RF of Kurnool Division for grant of quarry lease for Road metal in favour of Sri G.Maddilety Reddy and requested to resubmit after attending the following omissions.

1	The District Forest Officer, Kurnool has prepared the scheme for Raising CA in the SZA with belt of 7.50 mts from the outer peripheral boundary of the proposed mining area and also clubbed the enrichment plantation proposed to raise in the degraded forest land which is equal to 1 ½ time of SZA. The scheme should be separated by the following.	It is submitted that, the separate schemes were prepared for Raising of CA in the SZA with belt of 7.50 mts from the outer peripheral boundary of the proposed mining area and enrichment plantation over one and half times of the SZA in the degraded forest land. The same were included in the Part-II proposal booklet at page nos. 193 to 216 for kind perusal.
2	The outer periphery of the SZA by leaving 7.50 mts width along outer periphery of proposed mining area is to be fenced.	It is submitted that, 748 Rmt length fencing was proposed to the outer periphery of the SZA by leaving 7.50 mts width along outer periphery of proposed mining area with a financial outlay of Rs.7.405 lakhs and the same was included in the SZA scheme. The scheme details were included in the Part-II proposal booklet at page nos.193 to 196 for kind perusal.

3	The CA on SZA is to be raised in 3 Rows by following avenue plantation models.	It is submitted that, as per instructions of the Conservator of Forests, Kurnool on 26.03.2021, 2 Rows with 3x3 espacement avenue plantation model was proposed for raising of CA on Safety Zone Area and the same was included in the SZA scheme and in the Part-II booklet at page nos.193 to 204 for kind perusal.
4	Sufficient watering provision to plants and importation of soil if necessary etc should be projected in the scheme.	It is submitted that, the sufficient watering provision to the plants and importation soil was proposed in the scheme and the same was included in the Part-II booklet at page nos.193 to 204 for kind perusal.
5	Examine to proposed fencing to CA area proposed for raising plantation wherever is necessary.	It is submitted that, 719 Rmt Barbed wire fencing wherever necessary was proposed in the Compensatory Afforestation area and the same was included in the Advance operations data sheet in the CA scheme. The same was included in the Part-II booklet at page nos.166, 175 & 177 for kind perusal.

In view of the above, I submit herewith the proposals in hard copy in (6) sets along the CDs and also the proposals were uploaded in web portal (www.parvesh.nic.in) for further processing of the proposal under Section 2 of Forest (Conservation) Act, 1980.
