(i)	It is seen in the Part-II and site inspection report of the DFO, Athgarh Division that the proposed forestland involves in the proposal for diversion is of Eco-class-II, which covers littoral and swamp forests.	-	The compliance has duly been reflected in the Part-II and site inspection report which is enclosed in the DP.
(ii)	The check list-7 showing details of forest land involved including 1.810 Ha Revenue forest land located in two separate villages (Bhogara and Chandrabalishyampur) has not been authenticated by the Tahasildar concerned.		The land schedule over 1.810 ha Revenue forest land involved in this project has been authenticated by the Tahasildar, Athgarh which is enclosed in DP.
(iii)	The tree enumeration list of the involved forest land over 1.810 Ha has not been furnished by the DFO, Athgarh Division and nothing has been mentioned on it in Part-II or Site inspection report. But it is revealed from the DP that R.O, Athgarh has report to have submitted the tree enumeration list over the revenue forest land for both the villages to DFO, Athgarh vide his Memo No.854 dt.3.9.2019.Further no tree enumeration list over non-forest land of 12.404 ha (Govt.non-forest land-2.965 Ha+ Pvt.land-9.439 Ha)located in six villages has not been submitted.	295 to 137	As per tree enumeration list of 4.495 ha total forest land involved in this project, only 2107 nos of trees have been enumerated from 2.685 ha reserve forest land and no tree growth is available over 1.810 ha revenue forest land. Further as per joint enumeration list, no tree growth is available on 12.404 ha total non-forest land involve in this project, which has been reflected in the part-II and site inspection report of the DFO, Athgarh.
(iv)	The forest land involved in this project has been mentioned as 4.495 ha in the proposal and in Memo No.2441 dt.12.6.2020, it has been mentioned 4.0785 Ha.		Complied, and it is seen that as per Memo No.2141 dt.12.6.2020, nothing has been mentioned as 4.0785ha instead of 4.495 ha forest land.
(v)	The Topo sheet No.F-45T10 showing proposed non-forest private land identified for CA at village-Khanduali has not been authenticated by the Tahasildar concerned.
