1	Project proponent is requested to re-assess the technical requirement of drainage at specific sites in view of the width and diversion area of the road.	The User Agency has informed that Roorkee-Laksar- Balawali motor road (sh-26) passes through highly densed populated areas, such as Dhandhera, Nagla Imarti, Landhora, Basedi and laksar etc. Drainage of domestic and Monsoon run off discharge is a vast problem in all the habitations and having water logging in most of the habitations during Monsoon season. Sanction for strengthening and widening work of km. 1 to 19 of this road has been granted under Central Road infrastructure fund. Drainage work of habituated areas lying on the road, is also provisioned along both sides of the road. But the land having been the reserve forest land, the drainage work cannot be taken up, until the transfer of forest land. Further it is also to mention, that as per the actual minimum requirement of land for construction of drains and accordingly minimum requirement of felling the trees, the proposal have been re- assessed and the minimum required number of trees i.e. 527 in lieu of 984, have been taken.

The User Agency has informed that Roorkee-Laksar- Non-Forest Land is 40.71 ha. State Govt, is requested to provide information at para B in Part I.

Balawali motor road (SH-26) exists prior to year 1960. Total area of R.O.W. held by this road was 48.03 Hectares out of which 7.32 Hectares land (2-meter-wide strip on both side of road) were declared as reserve forest land vide G.O No. 115/XVI/331-50 dated 10.02.1960. Hence that net non-forest land area currently is 40.71 Hectares. Further it is also to mention, that the information regarding non forest land could not be entered in Para B of part 1, as the PARIVESH Portal is not supporting to edit the information entered earlier by the User

(ii)	Density is mentioned as 0.2 for 984 trees in 7.32 ha. area which appears less. It is requested to provide clarification in this regard and provide correct	as the PARIVESH Portal is not supporting to edit the information entered earlier by the User Agency. Same was also informed vide this office letter no. 2250/4C dated 21.11.2022 According to the assessment of 527 trees capable of being felled, the average density of plantation in the affected protected forest area has been estimated at 0.2.
