Refer to your office online EDS dated 25.03.2025 on the subject cited above.

In this context DFO Bilaspur has submitted that several cases pertaining to the diversion of small patches of forest land are currently under process in Bilaspur Forest Division. To fulfill the Compensatory Afforestation (CA) required against this diversion, a compact patch of 10 hectares of degraded forest land in DPF Jabliyana has been identified. This area has been proposed to accommodate the CA obligations of all such petty diversion cases collectively.

It is certified by DFO Bilaspur that no plantation activity has been carried out on the proposed CA patch. A formal undertaking to this effect is enclosed herewith.

The required documents, including the KML file of the compact CA patch, SOI digital map, toposheet/site suitability certificate and detailed CA scheme, have already been uploaded online in Part-II of the proposal./

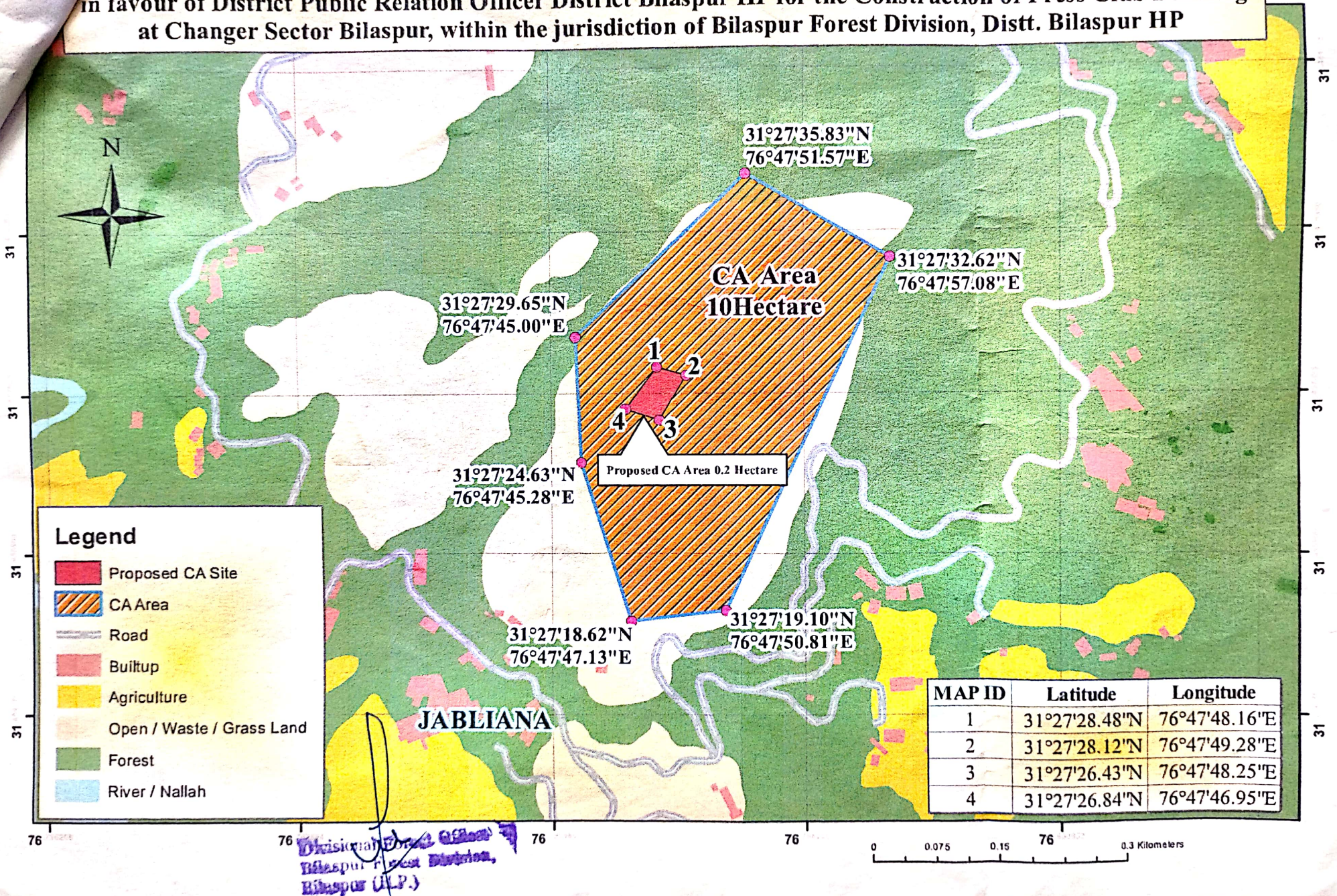

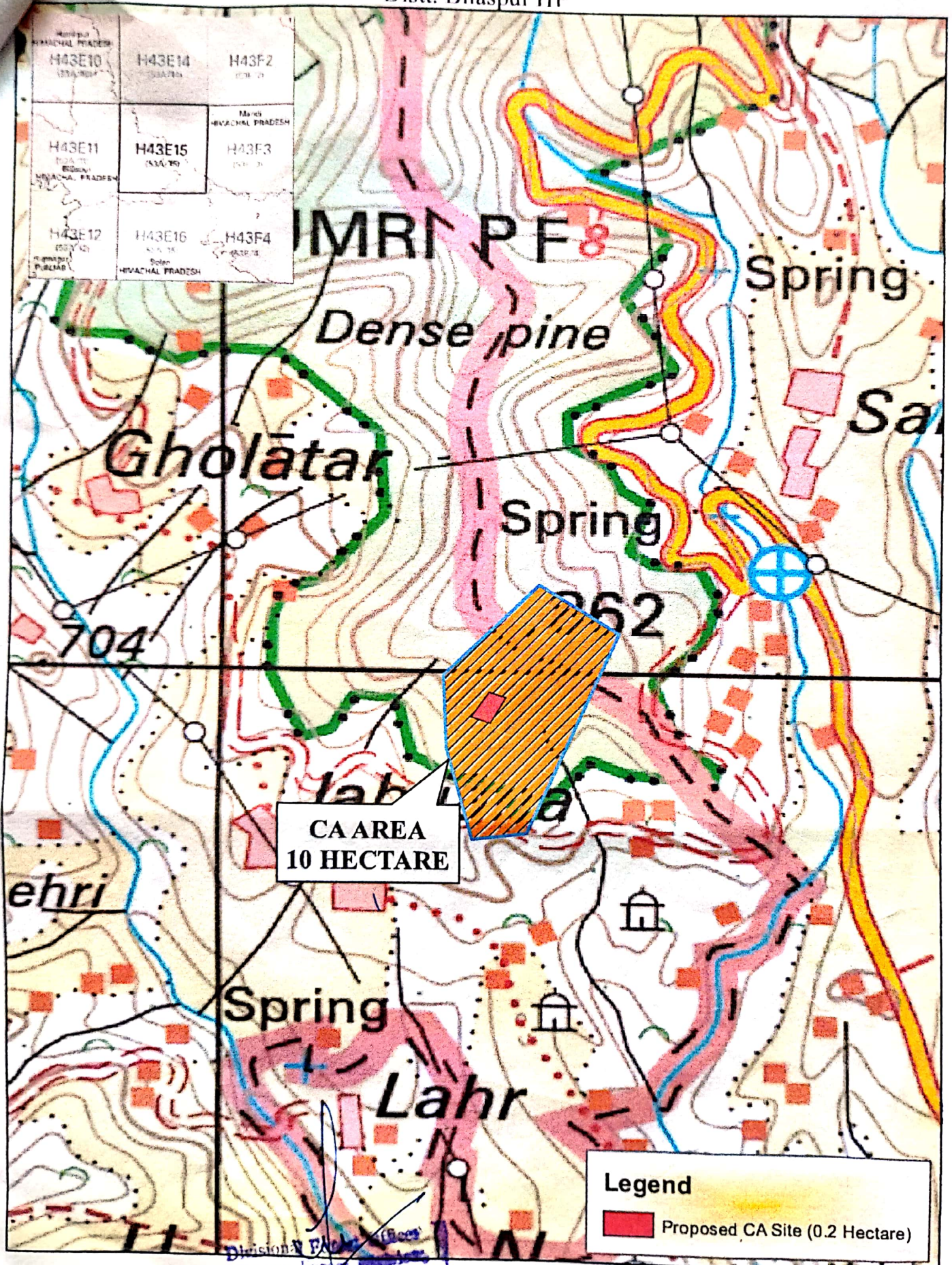

 Distt. Bilaspur HP




