- 2. The pointwise reply to the observation as raised vide your above referred communication is submitted as below:-
- 1. The revised Authorization letter has now been uploaded in online part-I.
- 2. Administrative approval letter and copy of Budget Book has been uploaded in online portal against additional information at Sr. No.13.
- 3. Cost of the project shown at Part I, A-I (vii) has been revised.
- 4. In Part-I, C (iii) & (iv) the toposheet number has now been mentioned in online Part-I.
- 5. The cost- Benefit Analysis has been revised as per the latest NPV rates.
- 6. Revised KML of the instant proposal has been uploaded.
- 7. i) As per DCF Kinnaur no approval for diversion under the provision of FCA, 1980 has been obtained.
  - ii) DCF Kinnaur has intimated that the existing road was not constructed prior to 1980. The existing road i.e Homte bridge to Masrang road Km 0/0 to 1/0745 was constructed by Panchayati Raj Department GoHP after obtaining necessary approval under Section 3 (2) of FRA 2006. DCF Kinnaur has accorded necessary approval for diversion of 0.6981 ha forest land for

construction of existing road vide letter No. 11685 (The documents uploaded as additional information under Sr. No. 4 of Part II).

- iii) The existing road has already been incorporated in the present proposal of DA.
- 8. The road appearing as parallel road in the KML file was erroneously marked in the KML file. The proposed road is not going parallel to the road which has already been granted approval under FCA (proposal number 36478/2018) In fact both the roads shall meet at Bhaba Top. KML file has now been corrected and uploaded.
- 9. Revised layout plan duly authenticated by the DFO has been uploaded in online Part-I in additional information at Sr. No.14.
- 10. Revised Joint Inspection report has been uploaded in online Part-I in additional information at Sr. No.17.
- 11. Geologist Report as desired has been uploaded in Part-I, additional information at Sr. No.24.
- 12. The conservation plan for all existing water sources and drain within and adjacent to the proposed site has been prepared and uploaded in Part-I, additional information at Sr. No.26.
- 13. Enumeration list has been uploaded as Part-II, additional information at Sr. No.2 and also intimated that enumeration of trees was carried out during December, 2021 in proposed DA i.e. UPF-28. As far as question regarding providing of separate enumeration list of trees for dumping site is concerned DFO Kinnaur has intimated that no trees are falling in the DA of dumping site.

Now the area of compensatory afforestation 9.60 ha has been proposed in UPF-Kakstal in Nichar beat, block and range of Kinnaur Forest Division.

- 25. The proposed area of CA is UPF and the prescription of working plan is uploaded as additional information.
