Further sanction letter from Airforce Authorities has been endorsed through online portal [Form- A Part I under item no. 1 in additional information details] which is once again enclosed herewith. Also approval accorded by Competent Authority at Ministry of Road Transport & Highways vide letter dated 04.11.2019 to develop the subject Emergency Facility is also enclosed herewith.

5	Total number of trees in the area and total number of trees proposed to be felled.	A total of 1419 trees have been identified by forest department and proposed to be felled. List submitted in Form A, Part-II under head 4 (ii).
6	The approval letter of the existing road along with a brief history about its existence is required to clarify if clearance for diversion of forest land under FCA was sought earlier or not.	History of forest clearance, already obtained by NHAI has been submitted through online portal under head B-1 of Form A, Part- I. Copy of the final approval of forest diversion received from MoEFCC is also enclosed.
7	In case of change of user agency (From that of previous diversion) CA should be proposed on equivalent NFL.	Not applicable as NHAI has earlier obtained the forest clearance and user agency is same for both the proposals.
8	CA scheme has to be revised as per FCA guidelines to include 1000 plants per Ha.	CA scheme has been prepared according to FCA guidelines to include 1000 plants per Hac. (700 plants by seedling+300 plants by seed sowing).
