
2. The point wise observation raised vide above referred communication is attended as under:-

The detailed list of approved existing proposed projects in the river basin/rivulet area/ landscape showing Evacuation Transmission Plan of each project alongwith their impact has been prepared by the user agency and uploaded online Part-I in additional information detail column. The user agency has submitted the Evacuation plan which is enclosed herewith.
 - ii. The Geo referenced map. Totosheet and KML file showing boundaries of nearest PA and its ESZs. Location and distance of HEP within 10 KM of nearest PAs and its notified ESZs has been uploaded online Part-I C(iv),(iii) and C(ii)(a), the said project has been approved by the competent authority after the completion of codal technical formalities.
 - iii. The detail regarding cumulative impact Assessment and total carrying capacity of river/ rivulet has been uploaded at Sr. No. 38 against additional information detail of Part-I
 - iv. The proposed area for the project has been corrected and revised KML file with correct area has been uploaded online Part-I.
 - v. The proposed components have been marked in the KML file alongwith legends.


