

Kind attention of the State Govt. is invited to the references cited.

The CF, Rajanna Circle, Siddipet in the ref 8th cited has informed that the Integrated Regional Office, MOEF&CC GOI, Hyderabad vide ref 6th cited has requested to realign road along the boundary of the forest land. On the above, the Executive Engineer, R&B Division Kamareddy vide Lr.dt.07.11.2022 has submitted that resurvey was conducted by the R&B authorities and has reported that it is found that the realignment is not possible due to following reasons:

1. Presence of grave yard and in continuation houses of Tandoor village.
2. This road connects two National Highways i.e Hyderabad - Medak- Bodhan road (NH.765) and Sangareddy- Nanded - Akola road (NH161). Hence the minimum radius desired is 400meters in accordance Indian road congress code IRC SP84-2014.
3. If the EE R&B try to use existing road to the extent possible, they have to introduce curves which are less than 400m radius by introducing the S curve and the road is prone to accidents.

Further, it has been reported that the Executive Engineer, R&B Division, Kamareddy has stated that it is not possible to realign the road. However the proposed alignment was proposed duly using the maximum extent of the existing road on the forest land (i.e from 0/45 to 1/100) and deviating from the existing road with radius 405 mts and just abutting the graveyard.

It has been further informed that the Executive Engineer, R&B Division Kamareddy has requested to kindly consider alignment already proposed.

Copies of the report of CF, Rajanna Circle, Rajanna with necessary enclosures are sent herewith for necessary action and with a request to accord Stage-I approval for the project at an early date.
