

In inviting a kind reference to your memo on the captioned subject, it is to inform you that as per Letter No. 138 dated 31.03.2022 (Copy enclosed as **Annexure-I**) of the Dy. General Manager (Elect.), EHT (Construction) Division, OPTCL, Jeypore, the extent of violation area is 0.04 Ha. i.e. (7.8MtrX7.8MtrX 3 Towers=182.52Mtr, 10.3MtrX10.3Mtr=106.09Mtr & 9MtrX9Mtr=81Mtr Total 369.61 Sqmtr or 0.04 Ha.).

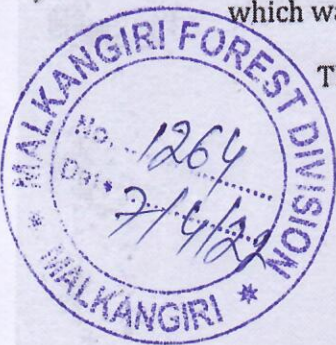
Sir,

Sir,

In continuation to this office letter under reference-ii, it is to state that, the work was under the jurisdiction of the Sri L. K. Panda, the-then Deputy General Manager (Elect.), EHT (Construction), Division, OPTCL, Jeypore and executed for the interest of OPTCL. However, while executing on the non forest land, inadvertently few towers got erected on forest land measuring only 0.04 Ha. from 7th March 2019, on account of error in identifying boundary of non forest-forest zone, for the fact that people are on occupation and use of such land which misled the field staff. No further progress of work was done soon it was found that the line is entering forest patches.

It is therefore submitted that any violation caused by erection of towers on forest land is due to mistake of fact and not a deliberate, intentional act on the part of OPTCL to breach forest Act, rules which may kindly be condoned.
