With reference to your letter 3<sup>rd</sup> cited, I am to inform that in the reference 4<sup>th</sup> cited (copy enclosed), the Principal Chief Conservator of Forests & Head of Forest Force has stated that the Executive Engineer, Panchayat Raj (PIU) Division, Srikakulam has identified non-forest land to an extent of 10.25 ha in Surjini Revenue Village of Meliyaputti (M), Srikakulam District for the following (5) road proposals which includes the present proposal for CA (sl.no.3) purpose to have single patch and to enable the Forest Department to effectively manage the newly planted area.

No.5-2/2017-FC, dated: 28.03.2019, the District Forest Officer, Srikakulam has prepared CA scheme proposals for 32.30 ha for the following Eight (8) projects with the financial outlay of Rs.180.613 lakh. Out of Eight (8) projects, the CA scheme for the subject proposal (sl.no. 6) for diversion of 1.33 ha forest area is

arrived on proportionate basis is Rs.8.16 lakh for a period from 2022-23 to 2033-34 with 10 years maintenance. The CA Scheme, map, Site suitability Certificate and other related certificates are enclosed herewith.

Further, I am to inform that the Principal Chief Conservator of Forests & Head of Forest Force has stated that the District Forest Officer, Srikakulam has inspected the non-forest land offered by the User Agency for Compensatory Afforestation purpose on 18.02.2022 and stated that, the non-forest land offered by the User Agency for Compensatory Afforestation purpose is having dense vegetation and it is not possible to take up Afforestation in the area, the District Forest Officer, Srikakulam has identified suitable alternative degraded forest area in compartment No.263 of Jadupalli Forest block of Pathapatnam Range, Srikakulam division for raising compensatory Afforestation with Teak and other miscellaneous species and would require SMC structures like Percolation Tanks/ Cattle proof trench etc.

I request you to consider above additional information and obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under Section- 2 of Forest (Conservation) Act, 1980, for diversion of 1.33 ha. of forest land in Compartment No. 409 & 411 of Kotturubattili RF, Srikakulam Division for formation of road from Pandra road 2/4 to Thumbali in favour of EE, PR (PIU) Division, Palakonda, at the earliest.
