





Subject:- Justification letter for Forest/Wild Life Land Diversion.

1. The project for construction of road from Kunderdhan to Mamankote Upper, Package No JK14-567, Stage I, Length = 27.00 KM has been sanctioned under Phase XI. Some stretches of road pass through the Forest/Wild life areas. The road namely Kunderdhan to Mamankote Upper has takeoff point from village Kunderdhan on existing GREF road from Budhal to Mahore. The construction of this road will benefit whole population of the area connecting 7 No of habitations of about 4000 souls.
2. Forest/Wild life area cannot be avoided as the alignment proposed is the only feasible alignment providing connectivity to the hamlets.
3. Hence, the diversion of the Forest/Wild life land is the only choice to construct the road.
