In your letter (2) cited above you have examined the proposal submitted in Part-I, II & III by the above user agency, Deputy Conservator of Forests, Ballari and this office respectively, has noticed that there is a revision of 0.1689 to 0.597 ha during field processing and subsequently EDS have been raised by you in respect of diversion of 0.597 ha (revised from 0.1689 ha) of forest land in Bukkasagara Sy.No.551, Venkatapura Sy.No.903, Kanive Thimmalapura Sy.No. 191, 133 & 258, Kamalapura Hobli, Hosapete Taluk, Ballari District for providing combined water supply scheme (CWSS) to Bukkasagara, Devasamudra and other 5 villages in Hospet Taluk, Ballari District in favour of the Assistant Executive Engineer, Rural Drinking Water Supply & Sanitation Department, Rural Water Supply Sub Division, Hospet, Ballari District. This apart it is also reported that, the user agency has made certain changes while re-submitting the proposal and introduced in in-correctness / in-consistency in some items of Part-I.

Accordingly, the Deputy Conservator of Forests, Ballari, has been directed to resubmit the revised proposal in 3 sets duly rectifying all the variations / shortcomings as noticed by your kindself in the letter (2) cited above. Further, the Deputy Conservator of Forests, Ballari, in his letter (4) cited above has resubmitted the revised proposal duly rectifying all the variations / shortcomings as raised therein for taking further needful action in the matter.

Further, while agreeing with the report which is comprising all the points of additional information / documents submitted by the Deputy Conservator of Forests, Ballari Division, as sought for therein for according in-principle Stage-I approval, I request your goodself to move the matter with the Government of India for taking further needful action in the matter.
