State Govt. need to clarify regarding date of notification/de-notification of WLS and if the notification is in existence, then the ESZ has been notified or not.	The GoHP has declare Govind Sagar as Wild Life Sanctuary vide Notification No. FFE-B- F(6)-18/99 dated 23.10.1999. There after above Wild Life Sanctuary has been de-notified by GoHP vide Notification No. FFE-B-F(6)- 11/2005-II/Govind Sagar dated 07.06.2013. Now the notification dated 23.10.1999 is not in existence.

A certificate in this behalf has already been submitted vide this office letter No. 8099 dated 24.03.2021. Further CA area 7.94 ha. is identify/selected from a patch of 11 ha. forest land. In this whole of 11 ha. patch, there are only 608 trees are existing as such.
