With regard to the above proposal, this office vide letter dated 01-07-2022 addressed to the Government of Karnataka had submitted the reply to the EDS query raised by the Government of India, Ministry of Environment, Forest & Climate Change, Integrated Regional Office vide Ref (1) letter dated 01-02-2022. Further, the Government of Karnataka forwarded the same to the Government of India, Ministry of Environment, Forest & Climate Change, Integrated Regional Office vide letter dated 25-07-2022.

In response to above reply, the Government of India, Ministry of Environment, Forest & Climate Change, Integrated Regional vide letter dated 22-08-2022 states that 'it is observed that the State Government has not submitted the action taken report w.r.t the violations of FCA 1980 as reported. Further, the information on action taken specifically w.r.t. the encroachment area reported i.e. 1.83 Ha for agricultural purpose is required'. Further, this office vide Ref (1) letter dated 29-08-2022 directed the concerned field officers to submit the information / documents as indicated above at earliest to this office.

Accordingly, the Deputy Conservator of forests, Ballari vide Ref (5) has submitted the following through the Chief Conservator of Forests, Ballari Circle vide Ref (6) to this office stating that the forest offence case was registered against Sri. Pujari Ganesh vide FOC No. 12/2020-21 dated 14-07-2020 who have encroached over an extent of 1.63 Acres (0.659 Ha) and investigation is under progress. The remaining area of 1.171 ha is encroached by the farmers, Sri. Pujar Dodda Tayappa and Sri. Pujar Sanna Tayappam since last 30-40 years. They have applied under Forest Rights Act, 2006 and these FRA applications are pending for verification.

The facts are submitted with the request to move to the Government of India for seeking Stage-I approval under the Forest (Conservation) Act, 1980.

Therefore, I am herewith submitting the following information regarding action taken w.r.t. the encroachment area reported i.e. 1.83 ha for agricultural purpose;

The Forest offence cases was booked against Sri. Pujari Ganesh vide FOC No. 12/2020-21 dt.14.07.2020 who have encroached over an extent of 1.63 Acers (0.659 ha). The FOC case is under investigation(FIR copy enclosed). Remaining area of 1.171 ha was encroached by Sri. Pujar dodda Tayappa & Sri. Pujar Sannda Tayappa, formers since 30-40 years and they have applied under Forest Rights Act, 2006. These FRA applications are pending for verification.
