Sub: Prior seeking prior approval under the Forest (Conservation) Act, 1980 for non-forestry use of 345.189 ha forest land including 6.919 ha in safety zone within the total mining lease area over 366.311 ha of Khandbandh Iron Ore Mines of M/s OMC Ltd in Keonjhar district, Odisha – Compliance to GoI observations regarding.

Sir,

In inviting a reference to the Government of India, MoEF & CC, New Delhi Letter cited above on the captioned subject, the following point-wise compliances to the observations of Government of India, MoEF & CC, New Delhi basing on the report of the DFO, Keonjhar Forest Division and RCCF, Rourkela Circle is furnished below-:

Observation (i)::KML/Shape file of the new non-forest land of 185.509 and degraded forest land of 104.30 ha identified for CA have not been submitted along with compliance report. The same needs to be submitted supported with their attributable information to enable the Ministry to undertake future monitoring of the area.

<u>Compliance-:</u> In compliance to the above, the RCCF, Rourkela Circle has submitted the KML/Shape file of the new non-forest land over 185.509 ha allotted in villages Balangi, Kerapai and Dalimguda under Thuamul Rampur Tahasil of Kalahandi District and 104.30 ha of degraded forest land identified in Baitarani RF in Keonjhar Forest Division pertaining to Khandbandh Iron Ore Mines of M/s OMC Ltd which is enclosed herewith in the form of a **CD**.

Observation(ii) -: Record of consultation and meeting of the Gram Sabha(s) in respect of 50.866 ha of forest land for which District Collector has issued certificate on 22.01.2017 based on SDLC proceedings dated 22.01.2017 has not been submitted along with the compliance. Similarly, proceedings of SDLC have also not been submitted in respect of 294.53 ha of forest land.

Compliance: In compliance to the above, the RCCF, Rourkela Circle has submitted the Record of consultation and meeting of the Gram Sabha(s) in respect of 50.866 ha of forest land for which Collector, Keonjhar has issued the FRA Certificate vide Letter No. 263 dated 22.01.2017 based on SDLC proceedings dated 10.02.2017 which are enclosed as Annexure-I series. Similarly, proceedings of SDLC and DLC meeting in respect of 294.53 ha of forest land submitted by the DFO, Keonjhar Division are enclosed herewith as Annexure-II Series.

In view of the above, the compliance to the observations pointed out by the GoI, MoEF & CC, New Delhi vide Letter No. 8-46/2018-FC dated 27.11.2021 is sent herewith for according final approval under the Forest (Conservation) Act, 1980 for non-forestry use of 345.189 ha forest land including 6.919 ha in safety zone within the total mining lease area over 366.311 ha of Khandbandh Iron Ore Mines of M/s OMC Ltd in Keonjhar district, Odisha.
