
Sir,

This is with reference to the above proposal and communication. In response to the observations of the IRO, MoEF&CC Jammu, the requisite documents have been uploaded by user agency and DFO Sindh and user agency. The point wise detail is given as under:-

v	DGPS Map of the CA site needs to be submitted/uploaded as currently Google map is uploaded	Revised DGPS map of the CA site has been uploaded under column 13(iii) of Part-II .

vi	Revised specific recommendation from the DFO as per format of part II needs to be submitted	Revised specific recommendation of the DFO as per format of Part-II has been uploaded under column 16.
