

Forest.





In continuation to this office memo no cited above on the captioned subject, it is to intimate that, as per status certificate submitted by the Tahasildar, Athgarh, that the total forest land over 0.074 Acres or 0.03 ha is mentioned as Revenue Forest land at Mouza-Madhapur involved for installation of High Power Transmission Line connected from the tapping point at Champia to Arati Steel Ltd for fulfillment of additional requirement of power by M/s Arati Steel Ltd, Ghantikhal under Athgarh Forest Division. The status of land mentioned in the Site Inspection Report as Revenue Forest, but in Part-II mentioned of the above forest land over 0.074 Acres or 0.03 ha as Revenue Forest private land.

Hence as per status certificate submitted by the Tahasildar, Athgarh the total forest land over 0.074 Acres or 0.03 ha may be consideration as Revenue Forest land in Part-II document of Forest Diversion proposal of the above project.
