3. That the approach should be constructed at least 9 inches lower than the PWD road by you at your own cost.
4. That the approach constructed in PWD land will be the property of PWD but shall be maintained by you and the department will have right to remove the access/approach without any further notice.
5. Take off point shall be improved according to land available to avoid accident.
6. That the permission is valid for 15(fifteen) years and after that it should be renewed every year.
7. That there should be no encroachment on PWD land in shape of fencing or boundary wall etc.
8. That the service land will have to be constructed as per plain approved by this office under the supervision of concerned Sub divisional Engineer as per guidelines of MoR&tH dated 24.07.2013 and IRC:2009.






