The RWS&S department has given CA land to an extent of 187.677 ha at one place i.e., in Nalgonda District.

Here it is informed that as regards to uploading the details of trees enumer in the Ministry's web portal, Sri R.K.Pathak of National Informatics Center was already requested to make provision for uploading the Excel Sheet during Work Shop conducted during November, 2015. The similar provision already exists for the projects uploaded or received prior to June, 2014. Further, the same was also requested to FSI and NIC during DSS training held during June'2016.

Mr. Pathak of National Informatics Center has promised that besides other facilities, this facility will also be provided in the online system. However, the same is yet to be provided. Hence, it is requested to arrange to make provision, for processing of proposals.
