2. The point wise reply to the EDS vide your above referred letter is submitted as below:-

1. The correct temporary employment generation details against column E(iii) of online Part-I has now been uploaded in the form of mandays.
2. Cost Benefit ratio alongwith the Cost Benefit analysis has now been uploaded at Para G online Part-I and hard copy of same is enclosed herewith as Annexure-A.
3. FRA certificate duly signed by the DC on prescribed format has now been uploaded at Para K online Part-I and hard copy of the same is also enclosed herewith as Annexure-B.
4. The scientific name of the species has now been mentioned at Para-ii online Part-I and hard copy of same is also enclosed herewith as enclosed herewith as annexure-C.
5. DFO concerned has reported that the development of passenger ropeway between Palchan (Kothi) Rohtang falls in 2/11 Kothi Tich C-1a and Manali-III forest within the jurisdiction of Kothi beat of Manali Range. Therefore the distance of the area proposed for diversion from the boundary of the forests has been given as nil as the proposed area falls within the jurisdiction of forest land. The necessary certificate is enclosed herewith as Annexure-D.

6. The comments of Pr.CCF (Wildlife)-cum CWLW in respect of furnishing Animal Passage Plan are enclosed herewith as Annexure E.
7. Revised Digital map and KML file for the proposed area for raising Compensatory Afforestation over an area of 18 ha. has been uploaded at appropriate place online Part-II.
