The District Forest Officers is requested to ascertain whether the proposed road is existence before 1980 and furnish the relevant map. | User agency has uploaded Survey of India topo sheet of year 2005, As per Survey of India sheet No.57P/13 of 1971 and 57P/4 of 1972 years the road is not mentioned thus it can't be ascertained whether the road was laid before 1980. |
