User agency has mentioned that in 1985 it was laid and repaired period to 2010, however no supporting documents were submitted. Thus, it is not possible to identify responsible subordinate staff and initiate action.
ii)	Report on correspondence made with the user agency/Rural Development Department on the reported violations.	Concerned staff details called for Joint Director & Project Director, Chengalpattu vide this office Ref.No.D/1120/2022 Dt.01.08.2022. (Copy enclosed)

iii)	Details about Right of way available (length and width) for the present road.	Right of way No.4 length 1089.20 mtr x 12 ft width
iv)	Present condition (length and width of carriage way and shoulder width) of the road and whether the present proposal involves any expansion work of road etc.	Present condition Road length 1089.20 mtr x 5.50 mtr width + 1 mtr on either side (shoulder width) and Divisional Engineer (H), N&RR, Chengalpattu has applied for forest land diversion of same area. So it doesn't involve any expansion work of road.

vi)	As per the survey of India topo sheet uploaded (Year not known) by the user agency, the proposed road is in existence and marked in the map. The District Forest Officers is requested to ascertain whether the proposed road is existence before 1980 and furnish the relevant map.	User agency has uploaded Survey of India topo sheet of year 2005, As per Survey of India sheet No.57P/13 of 1971 and 57P/4 of 1972 years the road is not mentioned thus it can't be ascertained whether the road was laid before 1980.
