I submit that, I am furnishing my remarks on the short comings pointed out in the above reference 8th cited for the proposal submitted for diversion of 0.90 forest area in Pennaiyar RF for the construction of Fuse plug in Sathanur Range of Thiruvannamalai Forest Division as detailed below.


Sl.No.	Short Comings pointed out	Reply
1.	In the CA scheme proposed, provision has been made for water augmentation work of construction of check dam at a cost of Rs.6.00 lakhs has been proposed. Justification for the check dam work in the identified CA scheme area has not been reported. This item may be removed.	The Construction of Check dam work has been removed from the proposal.
2.	Escalation cost in the nursery raising, planting and 1 st year maintenance works not provided.	As per the instruction issued, escalation cost has been added in the estimate and enclosed.
3.	From 2 nd year maintenance work to 10 year maintenance period, escalation cost provided in the work cost estimate itself and again escalation cost added in the abstract of CA Scheme. This needs to be deleted.	The escalation cost added again in the abstract of CA Scheme has been deleted.
4	For the planting of 1800 number of plants, engagement of four protection watcher has been provided. This seems to be not in order and needs revision.	The protection watcher provided in the estimate has been reduced from 4 nos to 1 no and the estimate has been revised accordingly.


All the short comings are rectified and the proposal is submitted herewith in triplicate for favour of further action.
