Sub:- Compliance of EDS for Proposal for diversion of 153.938 Ha. Forest land for construction of Kutulusingha Irrigation Project by Superintending Engineer, Angul Investigation Division, Angul.

In inviting a kind reference to the above cited memo on the captioned subject, it is to inform you that, as per your observation made or EDS raised against the above mentioned Diversion Proposal. The undersigned has prepared the Catchment Area Treatment Plan as per one-time cost norm as revised wage rate @ 326/- per man day.

Further, it is to inform you that, previously 970 Nos. of trees had been enumerated in Kutulusingha Revenue village (Patch No. 37,38,39,40,42). But, at the time of Site Inspection conducted by (i)RCCF, Angul, (ii)Divisional Forest Officer, Athamallik, (iii)Range Officer, Dhandatopa (iv)Forester, Dhandatopa and User Agency on dt.09.02.2022 and dt. 08.04.2022, it is seen that, some trees are outside the canal alignment. So as per revised tree enumeration, it is ascertained that, another 169 Nos. of trees falling in the said area and are included in the revised tree enumeration report.

Hence, the revised diversion proposal alongwith revised tree enumeration report, DGPS Maps in 03 sets are sent herewith to your good office for approval of Part-III and onward transmission to the higher quarter.
