With reference to above mention subject factual report is as-

EDS 1 – Working plan/Management plan prescription has not been submitted along with voluntarily of the area prone to soil erosion.

Fact – In this proposal as per model soil erosion and moisture conservation work is included in CA Scheme.

EDS 2 – NPV is applicable in the proposal, hence certificate of NPV calculation is required.

Fact – NPV calculation certificate has prepared as per your order & Direction.

EDS 3 – Estimate of CA is not as scheme provided. 1000 plants per to be planted at the site. The proposed site is not suitable for 1000 plants due to presence of vegetation.

Fact – As per model of CA is corrected and proposed site is suitable because in advance year site clearance including cutting of grasses scrub prosopis juliflora and bushes for bunding key lines vegetative fencing and other such work is included in CA.

EDS 4 – Status of 25 trees whether they are to be felled or not clarify it.

Fact – Yes, 25 trees of prosopis juliflora will be felled.

EDS 5 – Copy of notification of forest land has not been submitted.


