It is submitted that, in the reference 3rd cited, the Government have informed that on scrutiny of the subject proposal, it is noted that exemption of provision of CA for this project is not applicable presently and para 4.4 of Chapter-4 of comprehensive guidelines relating to General approval for public infrastructure projects in LWE District was expired by 31.12.2020 and requested to furnish CA land details for further processing of the proposal.

In view of the above, the Executive Engineer, Panchayat Raj(PIU) Division, Paderu has identified Non-Forest Land over an extent of 25.52 ha in Sy. no. 418-P of Kommika (V), Koyyuru Mandal, Visakhapatnam District for all the following (9) road proposals which includes the present proposal for CA purpose to have single patch and to enable the Forest Department to effectively manage the newly planted area. The Divisional Forest Officer, Narsipatnam has inspected non-forest land offered for CA purpose on 14.02.2022 and submitted CA Scheme proposals.

Accordingly, the Chief Conservator of Forests, Visakhapatnam Circle, Visakhapatnam in the reference 5th cited (copy enclosed) **has submitted CA Scheme proposals to 25.52 ha {single patch involving (9) projects} with a financial outlay of Rs.124.77 lakh . Out of (9) projects, the CA scheme for the subject proposal of 1.23 ha, arrived on proportionate basis is Rs. 6.01 lakh commencing from 2022-23 to 2033-34 with 10 years maintenance in the non-forest land identified by the User Agency in Sy. no. 418-P of Kommika (V), Koyyuru (M), Visakhapatnam District for Compensatory Afforestation.** The CA Scheme, authenticated map of non-forest land, Site Inspection report and other related certificates are submitted herewith.

Government are requested to take necessary action for onward submission of the proposal to the Government of India, MoEF & CC, IRO, Vijayawada to accord clearance under Section-2 of Forest (Conservation) Act, 1980 and amendments therein.
