

4	List of proposal as submitted to Hon'ble High Court by HPPWD may be provided and Sr. No. of the proposal may be mentioned.	The road namely Kandha-Murhala appearing in the list of Hon'ble High Court at Serial No. 405 copy of the same is enclosed herewith for ready reference.
5	The scientific name of the trees has not been mentioned in online part-II, whereas scientific name should be mentioned in bracked where no option is available in drop box.	The scientific name of the trees mentioned in the general abstract which has already been placed at Serial No. 3.
6	The detail against the para 11 (i) (b) may be furnished online Part-II.	Needful has been done.

7	The CA scheme is not correct, the complete CA scheme on current wage rates (with norms) alongwith 10% annual increase is required to be prepared and uploaded against the appropriate column. Further, the digital map and toposheet of CA site as uploaded online are photocopies hence original maps may be uploaded.	The CA Scheme @ 1100 plants per ha. has been prepared as per the rates approved by Pr. CCF (HoFF) HP Shimla for the year 2023-24 (copy of CA Scheme is enclosed herewith duly signed by the undersigned).
8	As per the inspection report constituted for the violation cases and detail furnished in online Part-II, some part of the road has already been constructed by local people/Panchayat whereas, as per the site inspection report, the violation stated to have been done by user agency which need to be rectified/clarified.	It is correct that the HPPWD authority has reported during the time of site inspection that the violation has not been occurred by the HPPWD and violation made by the local people and Gram Panchayat. In compliance of the observations the violation date has been obtained when the joint inspection made by the Joint Inspection Committee on 05.11.2020 (copy enclosed).
9	The detail of villages to be benefited has not found uploaded online by user agency. Further, bill of Penal NPV has not been uploaded.	The villages to be benefited by constructing Kandha-Lot-Murhala road has been prepared by the Concerned Kanungo and duly verified by the user agency as well as undersigned. The photocopy of the same is enclosed herewith.
10	In the KML file the private land has not been marked in different colour which may be marked accordingly.	In the KML file the private land has been marked and uploaded in the MoEF Portal.
11	The distance certificate of PA has not been found uploaded online.	The distance certificate of PA has been uploaded in MoEF Portal and copy of the same is enclosed herewith in duplicate.
