In inviting a kind reference to your above cited memos on the subject, it is to inform that the DFO, Malkangiri Forest Division vide his Memo No. 3564 dated 05.10.2021 (copy enclosed) has submitted the compliance as follows-

1. State Govt. has informed that the proposed Air strip includes construction of runway, approach road and airport terminal etc. However, the State Govt. has not furnished the detailed purpose-wise break-up of total land involved in this project.

Compliance-

The purpose wise break-up of total land involved in this project is uploaded in Parivesh portal. More over the information of such break-up of total land involved in this project is furnished herewith as **Annexure-1.**

2. The user agency has not uploaded KML file of forest land proposed for diversion in Parivesh web portal of the Ministry.

Compliance-

Now the user agency has uploaded required KML file of forest land proposed for diversion in Parivesh web portal of the Ministry. In this regard the revised Part-I portion of application "Form-A" is submitted herewith as **Annexure-2**

3. The non-forest land identified for C.A. is not contiguous to forest area. Further, the DFO, Malkangiri in C.A Scheme has also mentioned that the identified C.A. land is at distance of 2.00 Km from Bhimaram PRF. Hence, new non-forest land for C.A. contiguous to forest area may be identified and revised C.A. scheme along with Sol Toposheet, Geo-reference map & KML file may be submitted.

Compliance-

New Revenue land of 13.350 ha under the control of Revenue Department classified as "Parbat" in village Phulagandhi under Chitrakonda tahasil in Malkangiri district has been indentified for Compensatory Afforestation. The revised C.A scheme has been furnished herewith as **Annexure-3** with the following document/ reports –
