In compliance to the reference 3<sup>rd</sup> cited and in continuation of the reference 5<sup>th</sup> cited, it is submitted that the following are the documental evidences in connection with formation of road from Pandirimamidi to Chavitidibbalu obtained from the user agency i.e., Executive Engineer, R&B Division, Rajamahendravaram vide reference 4<sup>th</sup> cited. The User agency has furnished the survey of India Topo sheets 65-G/15 and 65-G/14 to ascertain that the above said road was existing prior to 1980.

The said road is passing through non-forest land (Revenue land) and Forest land as detailed below.

1.	Road outside RF	<b>A TO B: Pandirimamidi to Bhimavaram</b> The existing road from Pandirimamidi to Bhimavaram is passing through the revenue villages Tatiwada, Gogumilli, Bandapalli, Dibbaloveddi and Tallapalem which is existing out of Reserve Forest area of Bolagonda RF and lying in the revenue area.

	Road inside RF	The said road is continued up to Narsapuram village in the form of foot path cum cart road covering Bolagonda RF and Tadepalli PF. The details are as follows.
	Bolagonda RF	<p><b><u>B to C : Bhimavaram to Immdivaram</u></b></p> <p>The road passing through Bolagonda RF which is located in between revenue villages namely Bheemavaram to Immidivaram in Compt.no.395 &amp; 396 with a length of 2398 mtrs, width of 3.66 mtrs, within 10 yards RoW.</p> <p>The Bolagonda RF was notified U/s - 16 of Madras Forest Act (V of 1882) and published in Fort St.George Gazette dt.1st July,1941.</p> <p>The supporting documents / evidence as furnished by user agency are detailed below in proof of existence of road prior to 1980:</p> <p>The existing road was shown in the survey of India topo sheet no.65-G/15 which was surveyed in between 1974 - 75 and published in 1976(The road portion from Pandirimamidi to Bhimavaram villages has been demarcated on the map 65-G/15). The road is further continued in 65-G/14 and the same is highlighted in the map. A copy of the maps 65-G/15 and 65-G/14 are submitted herewith.</p>
2.	Tadepalli PF	<p>The remaining portion of the existing road is passing through the villages viz., Immidivaram, Gunjugudem, Vadapalli upto Narasapuram and falls in Tandapalli PF (Tadepalli PF) in Compt. no.750 over a length of 7471 mtrs and width of 3.66 mtrs.</p> <p><b><u>C to D: Immdidivaram to Gunjugudem</u></b></p> <p>The road falls in Tandapalli PF (Tadepalli PF) in Compt. no.750 over a length of 1545 mtrs and width of 3.66 mtrs. (annexure-I)</p> <p><b><u>D to E: Gunjugudem to Vadapalli</u></b></p> <p>The road falls in Tandapalli PF (Tadepalli PF) in Compt. no.750 over a length of 3255 mtrs, and width of 3.66 mtrs. (annexure-II)</p> <p><b><u>E to F: Vadapalli toNarsapuram</u></b></p> <p>The road falls in Tandapalli PF (Tadepalli PF) in Compt. no.750 over a length of 2671 mtrs, and width of 3.66 mtrs. (annexure-III)</p>

		<p>The Tadepalli PF was notified U/s-24 of A.P.Forest Act, 1967 (Act-I of 1957) vide G.O.Ms.656 Forests and Rural Development (Forest.III), dt.08-09-1975 and published in A.P.Gazette, dt.30-10-1975:</p> <p>The supporting documents / evidence as furnished by the user agency are detailed below in proof of the existence of road prior to 1980:</p> <p>The existing road continued is covered in Survey of India topo sheet no.65 G/14 which was surveyed in between 1969-70 and published in 1975 (The road portion area is highlighted on the map from Immdivaram to Narasapuram villages in Tadepalli PF portion). The road is shown by highlighting in 65-G/14 map.</p> <p>The village maps and FMBs furnished by the user agency indicates that the existence of road is passing through Immdivaram, Gunjugudem, Vadapalli and Narasapuram villages through Bolagonda, RF and Tadepalli PF as shown in the Survey of India Topo sheets and it was in existence prior to 1980 as per Revenue records. Copy of Village maps &amp; FMBs are submitted herewith.</p>
