In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC(pt). dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of right under the Schedule Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act,2006('FRA' for short) on the forest land proposed to be diverted from the non-forest purpose read with MoED's letter dated 5th February,2013 wherein MoEF issue certain relaxation in respect of linear project, it is certified that 4.869 Ha of forest land proposed to be diverted in favour of the Project Director, National Highway Authority of India, Shillong for widening of NH-44 (purpose of diversion of forest land)in East Jaintia Hills District falls within the jurisdiction of Narpuh Elaka, East Jaintia Hills District.

It is further certified that:

(a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 4.869 Ha of forest area proposed for diversion. A copy of records of all consultations and meetings of Forest Rights Committee(s), Gram Sabha(s) and District Level Committee are enclosed as Annexure I and Annexure II.

- (b) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and Gram Sabhas have given their consent to it;
- (c) The proposal does not involve recognised right of Primitive Tribal Groups and Agricultural Communities.
