3. The distance of diversion area from the boundary of forest has been uploaded at para 7 in online Part-II.
4. The revised CA Scheme of 425 plants has been uploaded in Part-II and hard copy of the same is enclosed herewith.
5. The user agency has uploaded the Administrative/ Financial Approval in additional information details at Part-I and hard copy is enclosed herewith.
6. The certificate indicating aerial distance of diversion of forest land from Dhauladhar Sanctuaries has been uploaded in Part-II and copy of same is enclosed herewith.
7. The user agency has submitted the detailed layout plan duly c/s by DFO, which is enclosed herewith.
8. The DFO has uploaded the revised NPV bill in additional information in online Part-II, and hard copy of which is enclosed herewith.
9. The user agency has submitted that village level committee has mentioned that proposal is for police post and residences. It is clarified regarding the same that it has been inadvertently mentioned so. The proposed land will be used only for construction of police post and not for any residential accommodation. Clarification submitted by User agency is enclosed herewith.

10. The user agency has submitted an undertaking that no residence would be constructed in the forest land proposed for diversion, which is enclosed herewith.

11. The user agency has uploaded the NOC issued by Gram Sabha in additional information at Part-I and which is enclosed herewith
