EDS Observation:

1. During Scrutiny of the land schedule furnished by the Tahasildar as on 25.10.1980, the following non-forest land are found as forest category but not included in the diversion proposal:

EDS Reply submitted by User Agency:

The User Agency has submitted the clarification as per the EDS raised by the Addl. PCCF (Nodal), Bhubaneswar, wherein the Tahasildar, Hemgir vide letter dated - 31.09.2023 has clarified that;

A.) The status of land pertaining to Plot no. - 94, 93/465, 377, 361, 310, and 19, 1, 42, 61 and 289(P) involved with a total area of Ac. 10.39 are Tenancy land as on 25.10.1980.

B.) The land under the category of Govt. Non-Forest land pertaining to Plot No. - 599, with an area of Ac. 4.40 of village Bankibahal, Plot No. - 20 with an area of Ac. 0.15 and Plot No. - 289 (P) with an area of Ac. 0.51 of village Kulda, making a total area of Ac. 5.06 are ascertained to be Govt. Non-Forest land, as on 25.10.1980 is Govt. Non Forest Land.

Further, the User Agency has submitted that, the Plot No. -94,93/465,377,361,310,19,1,42,61,289 have already been verified and considered under Tenancy land and respective payment has been disbursed by MCL through the Claims Commission setup by the Hon'ble Supreme Court of India, under the R&R policy.

And, as per the clarification submitted by the Tahasildar, Hemgir, and by the User Agency that, the nonforest land described above, which were already settled/leased out or recorded as non-forest as per the revenue records, and as per the recent Forest Conservation Amendment Act, 2023, may kindly be exempted from obtaining Forest Clearance.

In view of the above facts and requested to kindly forward the proposal for grant of Forest Clearance of 134.69 Ha for the purpose of Coal Mining in Kulda Expansion OCP of Mahanadi Coalfields Limited.

- A.) The status of land pertaining to Plot no. 94, 93/465, 377, 361, 310, and 19 involved with a total area of Ac. 3.03 are Raiyati/Private land of 1.) Kodandadhar Patel and 2.) Ratnakar Patel recorded under Hal Khata No. (Holding) - 5 & 22 of village Kulda, by the settlement c ganization during the last settlement operation held/completed on 25.06.1976. Though the classification of land is recorded as jungle during last settlement operation held/completed in 1976, in respect of the said land, as it is Raiyati/Private land of aforesaid recorded Tenants, and as such, it may not attract the provisions of Forest Conservation Act, 1980. Hence the status of land for Plot no. 94,93/465,377,361,310 & 19 as on 25.10.1980 is Tenancy land.
- B.) Similarly, Plot No. 1, 42, 61 and 289 (P) for the total area of Ac. 7.36 of village Kulda have earlier been leased out to three persons namely, Bhanwar Singh, Ghanashyam Seth & Sukadeb Naik vide lease case no. -1631/1975, 1622/1975, and 1619/1975 prior to the last settlement operation held/completed in the year 1976 but the classification of such leased out land is still recorded as Jungle & Patra Jungle. Hence the status of land for Plot no. 1,42,61 & 289(P) as on 25.10.1980 is Tenancy land.
- C.) The land under the category of Govt. Non-Forest land pertaining to Plot No. 599, with an area of Ac. 4.40 of village Bankibahal, Plot No. - 20 with an area of Ac. 0.15 and Plot No. - 289 (P) with an area of Ac. 0.51 of village Kulda, making a total area of Ac. 5.06 are ascertained to be Govt. Non-Forest land, although it has been recorded as Jungle and Patra Jungle. Hence the status of land for Plot no. 599 of Village Bankibahal & Plot No. 20 of village Kulda as on 25.10.1980 is Govt Non Forest Land.

Further, it is being submitted that these Plot No. - 94,93/465,377,361,310,19,1,42,61,289 have already been verified and considered under Tenancy land and respective payment has been disbursed by MCL through the Claims Commission setup by the Hon'ble Supreme Court of India, under the R&R policy.

Further, as per the clarification submitted by the Tahasildar, Hemgir, it is hereby submitted by the User Agency that, the non-forest land described above, which were already settled/leased out or recorded as non-forest as per the revenue records, and as per the recent Forest Conservation Amendment Act, 2023, may kindly be exempted from obtaining Forest Clearance.

In light of the above facts, we kindly request your consideration for granting an exemption to Kulda OCP from the requirement of applying for forest clearance for the non-forest land area of Ac.15.45 as pointed out by Adl. PCCF (Nodal), Bhubaneshwar and the proposal in complete may kindly be forwarded for grant of Forest Clearance of 134.69 Ha for the purpose of Coal Mining in Kulda Expansion OCP of Mahanadi Coalfields Limited.
