Sir, The Government of India, MoEF&CC, (FC Division) New Delhi vide letter dated 03/11/2022 has informed to submit back query compliance. The query compliance as desired by the Central Government is shown as under: -

i	As per DSS analysis, according to the administrative boundary provided by the Survey of India and available on the DSS web-portal, part of area proposed for diversion is falling within the state of Gujarat. This needs clarification and further necessary action as per ground situation.	The revised Survey of India Topo sheet map is enclosed herewith (Annexure No. 1 & 2) There is no encroachment in Gujarat state (Forest). All Kareghat Dam and Nalla diversion is only Maharashtra state Boundry.
ii	The State Govt has recommended the proposal subject to a condition that the CF Dhule and DCF Nandurbar shall ensure that the proposed area is outside the confines of Kareghat Conservation Reserve and submit SIR in this regard before Stage-1 approval. However, no such document has been submitted and the recommendation of the State Govt is therefore not complete in this regard.	The proposed area at present is Kareghat Conservation is not a 'Protected Area' as per the definition under WLPA, 1972. The Site Inspection Report is enclosed herewith alongwith geo-tagged photos (Annexure No. 3) Three visits done on Kareghat site DCF visited on site two times and CCF visited on site one time Kareghat 73.94 Ha is detached form Conservation Reservation.
iii	The DFO in his Site Inspection Report has mentioned that the forest land to be diverted is included in proposed Kareghat Conservation Reserve. The comments/ recommendation of CWLW in this regard shall be submitted.	The PCCF (WL), Maharashtra State vide letter No Desk-23 (2)/WL/Survey/C.R.No.136(Nodal)/2403, dat 17/12/2021 has given recommendation is stat that:- The proposed area is in Dhule circle, Nandurbar Division an area of 92.92 km. from the Kareghat Conservation, at present the area is not a 'Protected Area' as per the definition under WLPA, 1972. Hence, Wildlife Clearance not required. The report of the same is enclosed herewith as (Annexure No. 4 & 5)



xii	The State Govt has not submitted the copy of revenue documents indicating that the area proposed for CA is Non-forest land and free from all encumbrances. Further in the online part-1 of the application form, a copy of technical sanction order has been uploaded against the ownership proof of CA land. The reason for the same shall be explained.	The 7/12 extract and copy of the mutation entry is enclosed herewith as (Annexure No. 10 & 11)
xiii	The State Govt. has reported that 87.00 ha area has been selected for Compensatory Afforestation whereas the KML file comprising 152.161 ha area has been uploaded on PARIVESH. Moreover, the site suitability certificate has been submitted for an area of 91.26 ha This needs clarification and correct detail of the area proposed for CA along with the site suitability certificates, maps, KML file and CA scheme is required to be submitted.	Compensatory Afforestation area has been provided to Forest Department is 91.26 ha. but DCF, Dhule has given suitability certificate for 87.00 ha. remaining 4.26 ha. land for Compensatory afforestation is not suitable for plantation. xiv	Sattelite imagery shows the presence of Roads, Settlements and Agriculture land within the proposed CA site which indicates that the area is not free from all encumbrances. The State Govt shall ensure that the area free from all encumbrances is provided for the purpose of Compensatory Afforestation.	The proposed C.A area of non forest land. It is handed over to Forest Department, at present the proposed Compensatory Afforestation land is suitable for Plantation and free from encroachment all encumbrances. iv	The detail of the alternatives examined and the justification/ reason for selecting the proposed alternative shall be submitted.	The proposed site is considered downstream of proposed site the forest land will require more. If the project site is considered upstream of proposed site dam length will increase resulting requirement of more forest land and less water storage. As the area required for the proposed site is barest minimum the proposed site for the Minor Irrigation Tank at Kareghat, Tal. Nandurbar, Dist. Nandurbar is most suitable from Technical, Economical and Forest Point of view. There is no suitable alternative in non forest land.

viii	The Cost Benefit analysis is required to be submitted on the prescribed format keeping in view the revised NPV rates issued vide MoEF&CC letter dated 06.01.2022.	Revised cost Benefit Analysis is enclosed herewith as (Annexure No. 8)
ix	The State Govt. vide letter dated 12.09.2022 has informed that the total Non-forest land involved in the project is 77.54 ha, whereas the user agency in online Part-I has mentioned that the requirement of non-forest land is NIL.
