The said CA land is in Paschim Tilthai Mouja, and the quantum of the land selected amounts to 20 Ha, the said land as already mentioned has a density of less than 0.1, even as mentioned by CF(T), the said land is degraded and it may be kindly noted that it is not Moderately Dense Forest, there have been physical verifications which were conducted to confirm the same. It may be mentioned that in the DSS the area may be depicted as MDF, since there are vegetation in form of weeds, wild Banana and Mature Bamboo which also needs silvicultural operations etc, but the land is devoid of any major trees and is degraded.

So the above said quantum (20 Ha)of land which was proposed earlier for AR CA plantation may be reconsidered for the CA scheme for the same project.

The various details of the land are given below for your kind reference, it may be mentioned that the GPS Coordinates, the Topo sheet and the geo referenced map of the land has already been shared earlier.

## Tour note of Sh. Sushil Debbarma, CF(T)

Yesterday on 19 12.2020 I have visited the Proposal for CA site under North District at Panisagar area over 20 ha at Mouja Pachim Tilthai, Panisagar range, SDFO, Dharmanagar, SDM—Panisagar under North District, CS Plot No 50, Kh. No.2/2 and status of PRF, against the proposal for Bru migrants at Bikramjoy para. During my visit I was accompanied with Sh. Pranajit Dey, TFS, SDFO, Dharmanagar and other forest staffs.

There is no remarkable timber species available in the proposed site. A few bamboo ((*Melocanna bambusoides*) wild banana plants are there covered with climbers. The area is old jhuming area.

1) The proposed site is not part of any important land escape. ii) It does not affect any adverse impact of existing Bio-diversity, iii) the type of forest is Moist mixed deciduous forests 1/3/3C/C3, and density is around 0.1.

The area may consider as degraded area in regards to available of timber species.
