The Regional Empowered Committee (REC) in its meeting held on 17- 18 June, 2021 at Integrated Regional Office, Chandigarh has approved the proposal and authorized Regional Officer, IRO Chandigarh as Chairman of the REC to accord Stage-I approval with standard conditions after receipt of the following information:-

- (i) Dumping site number 2 bearing No. 7/400 may be shifted to another location since it is located in very dense forest.
- (ii) Detailed muck disposal plan to be submitted along with muck generation calculation sheet.
- (iii) Area statement in component wise break up of forest under B-2.4 in Part-I to be corrected to 6.05 Ha

The above said documents/information has been uploaded by the user agency. With the change of dumping site no. 2, the number of trees/poles involved in the proposed project has been reduced from 147 to 137. The revised enumeration list has been uploaded by the DFO Mahore.
