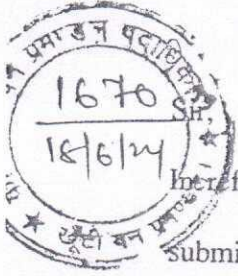

**Sub: Extension of validity period of Letter of Intent (LOI) issued for the grant of Mining Lease of Parasi Gold Block over an area of 75.273 Hectares to M/s Rungta Mines Limited vide letter no. Kha. Ni. (Ranchi/Gold)-18/2016-15-M/Ranchi dated 03.01.2018.**

Respected Sir,

1. As per the NIT dated 12.08.2017 floated by the Government of Jharkhand, e-auction for Grant of Mining Lease for Parasi Gold Block located in Ranchi District of Jharkhand, was conducted on 01.11.2017. Based on the highest final price offer, M/s Rungta Mines Limited was declared as the "Preferred Bidder" for Parasi Gold Block under Rule 9(4)(b)(iii) of the Mineral (Auction) Rules, 2015. It is relevant to point out that in the DGPS Map appended to the Tender Document, the size of the Parasi Gold Block lease area was shown as 75.273 ha.
2. Upon being declared Preferred Bidder, we deposited 1<sup>st</sup> instalment of the Upfront Payment amounting to Rs 1,52,64,046/- on 15.11.2017 in the form of Demand Draft payable to the Director of Mines.
3. Thereafter, the Director (Mines), Department of Industries, Mines & Geology, Govt. of Jharkhand had issued Letter of Intent (LOI) to Rungta Mines Limited vide letter no. Kha. Ni. (Ranchi/Gold)-18/2016-15-M/Ranchi dated 03.01.2018 which was valid for 3 years i.e. upto 03.01.2021. It may be noted that in the LOI, the lease area for the Parasi Gold Block was shown over 69.240 ha, which is was in conflict with the DGPS Map in the Tender Document, which had mentioned it as 75.273 ha.
4. That because of this discrepancy in the lease size area, our initial proposal for Mining Plan was returned by the IBM on 25.05.2018. Accordingly, we had vide our letter dated 01.06.2018 requested the Secretary, Department of Industries, Mines & Geology, Govt. of Jharkhand to resolve the discrepancy regarding the lease area size.

5. Finally, on 09.07.2018, the Director of Mines, Department of Industries, Mines & Geology, Government of Jharkhand issued a clarification that the as per the DGPS survey report, the area of lease is 75.273 hectares. Therefore, a period of more than 6 months was lost after the initial grant of LOI dated 03.01.2018 owing to discrepancy in the lease size area, which was totally beyond our control.
6. After the issuance of the clarification regarding lease area size, we have taken all steps for compliance with conditions of the LOI, which are enumerated hereunder:
  - i. We have deposited the 2<sup>nd</sup> instalment of upfront payment amounting to Rs 1,55,22,138/- and submitted the Performance Bank Guarantee(BG) no. 119/2018 dated 08.01.2018 for an amount of Rs 15,22,21,383/- vide our letter no. RML/BD/Parasi\_Comr/17-18/432 dated 09.01.2018 and the period of validity of the said BG is extended upto 10.01.2025.
  - ii. We obtained approval of Mining plan over 75.273 hectares by the IBM, Ranchi on 28.11.2018.
  - iii. We obtained Environment Clearance from SEIAA, Jharkhand on 26.10.2019.
  - iv. We submitted the Diversion proposal for Forest Clearance over Forest Land (i.e. F. C. application) on 03.12.2018 which has been forwarded to the Addl. Chief Secretary, Department of Forest, Environment & Climate Change, Government of Jharkhand on 29.11.2019. Further as instructed, we obtained FRA certificate on 19.06.2020 and submitted the same on 22.06.2020 to PCCF(Nodal), which was forwarded to the Principal Secretary, Dept. of Forest, Environment & Climate Change, Govt. of Jharkhand, Ranchi on 05.08.2020.

However, since then, our Forest Diversion Proposal is still pending at the government level for reasons completely beyond our control.

7. It may be noted that in the interregnum, because of the Covid-19 Pandemic, the Ministry of Mines, Government of India in exercise of the powers conferred under Section 20A of the Mines and Minerals (Development and Regulation) Act, 2015, inter alia issued a direction dated 14.10.2021 that the where the letter of intent was valid as on April 1, 2020, the period for execution of mining lease shall be deemed to have been extended for the period of 6 months from the date of expiry of the period prescribed or allowed under Rule 10(6) of the Mineral (Auction) Rules, 2015. In terms of the said direction, all such LOIs, including our LOI got extended by a further period of 6 months.
8. However in view of the fact that our Forest Diversion Proposal was still pending, we had submitted our request for extension of Letter of Intent (LOI) for a further period of 2 years as per provisions of Rule 10(6) of the Mineral (Auction) Amendment Rules, 2017 to your kindself vide our letter no. RML/BD/Parasi/20-21/176 dated 10.12.2020. Copy of our said letter dated 10.12.2020 is enclosed as Annexure-1 for ready reference.

9. Subsequently, we received letter no. Kh. Ni. (Vividh)-13/2019/1623/M dated 26.08.2021 from Joint Secretary, Department of Mines & Geology, informing us about a review meeting on the progress of Parasi Gold Block to be held under your Chairmanship on 03.09.2021 at your good office. In the said review meeting we had submitted the progress of the said Parasi Gold Block vide our letter no. RML/BD/Parasi/21-22/100 dated 03.09.2021 and again requested for extension of Letter of Intent (LOI) for a further period of 2 years. Copy of our said letter dated 03.09.2021 is enclosed as Annexure-2 for ready reference.
10. Further to the above, review meetings were fixed on 14.09.2021 vide letter Kh.Ni (Vividh)-13/2019/1769/M dated 09.09.2021, on 01.10.2021 vide letter no. Kh.Ni (Ranchi/Gold)-18/2016/1452/M dated 28.09.2021 and on 05.10.2021 vide letter no. Kh.Ni (Vividh)-13/2019/1478/M dated 01.10.2021 but all these meetings were postponed. Long periods have passed since we requested for extension of Letter of Intent (LOI) to your kindself but we are still awaiting the same till date.
11. Since, we have not yet been granted the extension of LoI, we again requested your goodself vide our letter no. RML/BD/Parasi/22-23/009 dated 05.05.2022 and letter no. RML/BD/Parasi/22-23/049 dated 14.06.2022 for extension of Letter of Intent (LOI) for a further period of 2 years (copy of letter dated 05.05.2022 and letter dated 14.06.2022 is enclosed as Annexure 3 & Annexure 4 respectively).
12. Furthermore, we received letter no. Kh. Ni. (Vividh)-13/2019/2041/M dated 23.09.2022 from Director (Mines), Directorate of Mines, Department of Industries, Mines & Geology, Government of Jharkhand, informing us about a review meeting on the progress of Parasi Gold Block to be held under your Chairmanship on 29.09.2022 at your good office wherein we again requested for extension of Letter of Intent (LOI) for a further period of 2 years.
13. Once again, we received letter no. Kh. Ni. (Vividh)-13/2019/2557/M dated 13.12.2023 from Director (Mines), Directorate of Mines, Department of Mines & Geology, Government of Jharkhand, informing us about a review meeting on the progress of Parasi Gold Block to be held under the Chairmanship of Secretary, Ministry of Mines, Government of India on 15.12.2023 at your good office. In the said review meeting we had submitted the status of LOI vide our letter no. RML/BD/Parasi/23-24/191 dated 15.12.2023 and again requested for extension of Letter of Intent (LOI) for a further period of 2 years. Copy of our said letter dated 15.12.2023 is enclosed as Annexure-5 for ready reference.
14. In view of the above, we humbly reiterate our submissions made in our letter no. RML/BD/Parasi/20-21/176 dated 10.12.2020, letter no. RML/BD/Parasi/21-22/100 dated 03.09.2021, letter no. RML/BD/Parasi/22-23/009 dated 05.05.2022, letter No. RML/BD/Parasi/22-23/049 dated 14.06.2022 and letter no. RML/BD/Parasi/23-24/191 dated 15.12.2023.

15. We submit again that we have been in complete compliance with all conditions of the LOI, and but for the pendency of our Forest Diversion Proposal at the government, the LOI conditions would have been fulfilled and the mining lease could have been executed. However, for reasons which are beyond our control, the forest diversion proposal has remained pending
16. In view of the foregoing circumstances, we submit that the following periods deserve to be excluded from the LOI validity period:
- The period between 03.01.2018 and 09.07.2018, during which there was a discrepancy in the lease size area in the LOI (69.240 ha) and the Tender Document (75.273 hectares), which was finally clarified by the State Government on 09.07.2018;
  - Period of 6 months, owing to the Ministry of Mines, Government of India direction dated 14.10.2021;
  - The period since 05.08.2020 on account of the fact that the Forest Diversion Proposal has been pending at the government level since 05.08.2020, and continues to remain pending till date.

We therefore humbly request to kindly grant an extension of the LOI by a period of 3 years and 5 months in accordance with (a), (b) and (c) above, with such period of 3 years and 5 months being kindly considered from the date of issuance of extension order of LOI.

17. Since the delay in the matter is beyond our control, we humbly and respectfully pray that our request be considered by your kind-self on an urgent basis. Furthermore, we also humbly pray that the process of grant of Forest clearance may also be kindly expedited in order to grant of Mining lease of Parasi Gold Block over an area of 75.273 Hectares to M/s Rungta Mines Limited at the earliest.

That after compliance of the required terms of payments of 2<sup>nd</sup> installment of the upfront payment and depositing of Bank Guarantee for the Performance Security, the immediate next obligation of the declared "Preferred Bidder" is to submit Mining Plan to comply with the conditions of the said LOI dated 03.01.2018 and adhere to the Sl. No. 18 of "Clause-12. Timetable" of the Tender Document - i.e. submission of mining plan by the Preferred Bidder to become Successful Bidder. Accordingly, on 28.02.2018 M/s Rungta Mines Limited requested the Director of Mines, Department of Industries, Mines & Geology, Govt. of Jharkhand vide its letter no. 


