Accordingly, the Deputy Conservator of Forests, Vijayanagar Division, Hospete has been directed vide this office letter (2) cited above, to submit the information/clarification about complete component breakup and the details of non forest transmission line and proposed wind farm (Bay-2), duly obtaining from the user agency and got it thoroughly verified.

On going through the additional information submitted by the Deputy Conservator of Forests, Vijayanagar Division, Hosapete, the following compliance on the 2 points as sought by by your goodself in the letter of dtd. 17-10-2022.


- (i) The complete component breakup required by the project proponent has been provided by the user agency and the same has been submitted.




- (ii) It is explicitly reported by the Deputy Conservator of Forests, Vijayanagar Division, Hosapete that oversightly the non-forest transmission line and proposed wind farm (Bay-2) was depicted as Sy.No. 240 instead of 239 of Agrahar village. Accordingly, it has been rectified as Sy.No. 239 of Agrahar village in the relevant maps and duly verifying the ground by the field officers of the jurisdiction.
