

This is with reference to the above proposal and communication. In response to the observations of the IRO, MoEF&CC Jammu, the requisite documents have been uploaded by user agency and DFO Billawar. The point wise detail is given as under:-

PCCF/FCA/3257/1318-19 dated 03.06.2022 regard to the Administrative Approval from the competent authority for the entire stretch of 6 Km of proposed road is not plausible, and this proposal can't be processed in absence of written Administrative Approval for 6 Km of road. In absence of written Administrative Approval for 6 Km road the proposal of diversion for 2.5453 ha of forest land in Billawar Forest Division may be recast corresponding to the 5 Km length of approved road | The proposal has been recasted for a length of 5 Km by the user agency and accordingly, forest area in this proposal has been reduced from 2.5453 Ha to 1.505 Ha. The requisite documents with regard to involvement of 1.505 ha of forest land in the proposed road has been uploaded by user agency/DFO/CF and Nodal Officer. |
| 2. | The clarification regarding passing of the proposed alignment through dense forest patch has not been given, as sought in the para no. 2(v) vide this office letter of even no dated 22-03-2022. | Clarification has been uploaded by user agency in Part-1 at Sr.No. 18 (additional documents) |

The Administrative Department is requested to kindly upload the revised recommendation for 1.505 Ha of forest land, before forwarding the proposal to the Integrated Regional Officer, MoEF&CC Jammu.
