In inviting a kind reference to your aforecited memo on the captioned subject, the Divisional Forest Officer, Baripada Forest Division vide his memo no.7556, dt.10.10.2023 has submitted compliance report on the points raised vide your memo under reference on the proposal for diversion of 0.890ha. of Revenue Forest land for establishment of Mayurbhanj College of Accountancy & Management at Maharajpur, PO-Takatpur in the District of Mayurbhanj to this office. The compliance report is furnished hereunder for favour of your information and necessary action.

1. Shape and KML file are not appended with the diversion proposal.

Compliance:-Shape and KML file in shape of CD has been enclosed in the Diversion Proposal.

2. In the instant case, the ROR area is 0.890Ha. and the DGPS map area is 0.894Ha. in form A of Part-I, the user agency has mentioned the forest area proposed for diversion as 0.894Ha. Thus, this area should be taken for the diversion proposal.

Compliance:-The User Agency vide his letter No.672/23, dt.04.09.2023 (Copy enclosed) has intimated that as per ROR, area of 0.890Ha. instead of 0.894Ha. has been changed in Parivesh Portal. Accordingly, the revised Part-I of Form-A has been enclosed in the diversion proposal.

3. Checklist is not countersigned by the RCCF, Baripada Circle.

4. In Sl. No.9 of Part-II, the DFO, Baripada Division has mentioned implying of that there is no violation. But, in Sl. No.18 of Site Inspection Report, he has mentioned about violation.
