

Proposal is in EDS mode, it should be in Draft mode to upload corrected KML files. User agency many times contacts NIC Delhi for uploading these KML files but they Refused the request of USER agency. These KML files Has been mailed to NIC Delhi on Dated 11.09.2015 but they told that Thease KML files couldn't be uploaded now. DCF (Central) also telephonically Directed on Dated 5 <sup>th</sup> October 2015 to submit these KML files in soft copy and Hardcopy to The Moef Office (Central Zone) Lucknow. <b>We have submitted these KML files in Four soft and hard copies to The DFO Baran.</b>
