Kind attention is invited to the reference 4th cited wherein the Chief Conservator of Forests, Wildlife Management Circle, Tirupati has called for proposals in Wildlife Formats as per the Guidelines / instructions of Government of India, MOEF, F.No.6-3/2003/WL-I (Pt-10, Dt: 05.10.2006 & F.No.11-327/2015-FC, Dt: 14.08.2015 and as per the instructions of the Prl. Chief Conservator of Forests (WL) & Chief Wildlife Warden Rc.No.50487/09/WL-1, Dt: 04.11.2009. In this connection it is submitted that the Prl. Chief Conservator of Forests, AP, Guntur in reference 1st cited has communicated the proposals under section 2 of Forest Conservation Act 1980 for diversion of 594.75 Ha falling in Wildlife Management Division Tirupati for Sri Balaji Reservoir and Mallimadugu Reservoir. Accordingly I have examined the proposals and also physically inspected the proposed diversion area and uploaded the relevant information pertaining to Part-II of the proposal in complete shape in the Ministry's (www.forestclearance.nic.in).

In this connection it is submitted that the user agency has uploaded the proposals in the Ministry's website (www.forestclearance.nic.in) for Forest clearance only and not uploaded/ submitted the proposals in Wildlife formats as required for NBWL clearance. In this connection it is submitted that the user agency will be addressed to submit the proposals and upload the proposals in part I and II in wildlife formats and soon after the user agency submitted the proposals, the same will be submitted along with opinion and recommendation of the Divisional Forest Officer and Officer in-charge of SV Sanctuary. Since it will take considerable time to submit the above, it is requested that the proposals as submitted for Forest

clearance may please be forwarded to the Prl Chief Conservator of Forests (HoFF), Andhra Pradesh , Guntur . Further it is submitted that the issue may please be addressed to the Prl Chief Conservator of Forests (HoFF), Andhra Pradesh , Guntur to issue suitable instructions to the user agency to submit / upload the proposals in the Ministry's website.
