I submit that, the specific remarks for the queries raised by the Conservator of Forests in the reference 7th cited is furnished as follows.

- 1) The Admitted Right of Way is three yards from erimalai to belluhalli and the access allowed to villages sattikal and alagattu for men and cattle to a width not exceeding three yards is mentioned in kesarkuli Reserved Forest


Fort st.George Gazette, Page no.831 dated.28.06.1892 is enclosed herewith for your kind perusal.

- 2) The village alagattu lies in morappur Reserved Forest near the intersection of kesarkuli Reserved Forest and morappur Reserved Forest. The third stretch lies entirely in kesarkuli Reserved Forest except near the intersection portion of the two Reserved Forests which is very minimal and difficult to be calculated in field as there are no clear Reserved Forest demarcations in the field. This portion is negligible when compared to the total diverted area (4.81Ha) and can be ignored.

Therefore, under the circumstances, I request that the proposal for diversion of 4.81 ha of Forest land in Kesarkuli Reserved Forest of Palacode Range in Dharmapuri Forest Division for formation of road from Seenkadu to Alakattu via Erimalai village may kindly be submitted for getting the concurrence of the Government of India.

Fort St. George, June 22, 1892.

No.300.--His Excellency the Governor in Council is pleased to declare, under the provisions of section 16 of the Madras Forest Act (V of 1882), that, from 1st October 1892, the area, the boundaries of which are set forth in the schedule appended to this notification, shall be constituted a "reserved forest."

SCHEDULE.

Area: 8132 Acres.

Date of Entry.	Name of Forest.	Civil District, Sub-Division and Taluk.	Boundaries.
1st October 1892.	95 Kasaraguli.	Salem. Dharmapuri.	SITUATION.-- On the eastern slopes of the Kotturmalai range between Kasaraguli and the Chinnar river.

BOUNDARIES--North--North-east.--Starting from a cairn on Kalthiltukaradu (rock) on the south-west boundary of Tirumalavadi mittah about three hundred yards north-north-east of Kasaraguli deserted village the line runs south-east along the demarcated surveyed south-west limit of the above mittah to a cairn at the most southern point of the above mittah; then a straight line due south for about one furlong to a cairn on the right bank of the Chinnar river.

East--South-east.--Thence south-west along the right bank of the Chinnar river to a cairn on Thammakal (stone) near the south-east corner of Morappur reserved forest No.36.

West--South-west.--Thence along the demarcated eastern boundary of Morappur reserved forest No.36 to a cairn on the village site of Kottayur; then a straight line east for about four hundred and forty yards to a cairn; then a straight line north for about four hundred and forty yards to a cairn; then a straight line west for about five hundred and fifty yards to a cairn on the east boundary of Morappur reserved forest No.36; then along the said boundary to a cairn south of field No.185 of Yerrimalai village; then a straight line north for about four hundred and forty yards to a cairn; then along a demarcated line west for about three-quarter miles to a cairn at the village site of Yerrimalai; then along the north boundary of Morappur reserved forest No.36 to a cairn on the north-west corner of the said reserved forest on the boundary between Hosur and Dharmapuri taluks about one thousand yards south of Kasaraguli deserted village.

West.-- From the last mentioned point north along the demarcated and surveyed boundary of Hosur taluk to the tri-junction stone between Tirumalavadi mittah, Hosur and Dharmapuri taluks; then north-east along the demarcated and surveyed south-west limit of Tirumalavadi mittah to the starting point of the northern boundary.

REMARKS.--Right of way is allowed over the undermentioned paths and to the undermentioned temples each to a width three yards; Nos.1, 2, 3 and 4 for men, cattle and pack animals and Nos.5, 6 and 7 for men only:--

1. Path from Kottayur to Tirumalavadi. It enters the reserve at Sengal Gundu (rock), runs east for about one mile and quits it at Kongarakal (stone).
2. Path from Yerrimalai to Belluhalli. It enters the reserve north of field No. 205 of Yerrimalai village, runs north-east and north for about one mile and quits it at Bodikutai (hillock). (near Kothumalai)
3. Path from Pikkili to Pennagaram. It enters the reserve at Thavaravanam kadu (land), runs south-west and south for about two miles and two furlongs and quits the reserve a little to the east of Thammarakal.
4. Path from Tirumalavadi to Pennagaram. It enters the reserve at Udupukulipallam, runs south for about three and a half miles and joins path No. (3) above at Ballarankollai (field).
5. Path from Kottayur to Pikkili. It enters the reserve south of Kottayur village, runs east for about two and a half miles and quits it at Thotapallam (ravine).
6. Path from Yerrimalai to Perumal kovil (temple) situated on a hill of the same name and about one hundred yards north-west of path No. (2) above.
7. Path from Yerrimalai to Mariamman kovil (temple) situated in the Bettanurkullai north of field No. 205 of Yerrimalai, runs north-west for about five furlongs to the temple. Access is also allowed to the well for men only to a width not exceeding three yards. Right to use the water for services connected with the temple from the adjacent well situated about one furlong north-west of the temple is also admitted.

The abovementioned two temples to be demarcated out with ten and five yards respectively on each side for of votive offerings.

Mariamman and Perumal kovils (temples) situated on path No. (4) above are demarcated out and held free reservation with a margin of twenty-two yards on each side of them for preparation of votive offerings. Right to use the water for services connected with the temples from the Chinnar river is also admitted. Access is allowed to the Chinnar river from the temples for men only to a width not exceeding three yards paths running east for about one mile and three-quarter mile from the temples respectively.

Villages of Sattikal and Alagattu with 8.38 acres and 15.99 acres of land are retained as enclosures and free from reservation with access allowed to the villages and the lands for men and cattle to a width not exceeding four yards from the south-west boundary of the reserve.
