उपरोक्त विषय के सम्बन्ध में आपको पुनः सूचित किया जाता है की उपरोक्त सड़क km RD 400 से शुरू होती है तथा km RD 22400 पर समाप्त होती है। उपरोक्त सड़क को शहर एवं गांवके हिस्सों जोकि km RD 400 से km RD 2000, km RD 11500 से km RD 15200 एवं km RD 21400 से km RD 22200 में चौड़ा करके चार लेन में बनाना प्रस्तावित है जिसका diversion का केस आपके विभाग में लंबित है।

इस सड़क के km RD 2000 से RD 11500, km RD 15200 से km RD 21400 तथा km RD 22200 से km RD 22400 को forest diversion में इसलिए शामिल नहीं किया गया है क्युकी इन किलोमीटर्स में विभाग द्वारा मंजूर अनुमान (approved estimate) के अनुसार केवल मौजूदा सड़क को ही strengthening (मजबूतीकरण) करने का प्रावधान है तथा widening (चौड़ा करने) का कोई प्रावधान नहीं है जिस कारण से इसको forest diversion में शामिल नहीं किया गया।।
