The proposal in the subject matter came up for discussion before the Forest Advisory Committee on 27/02/2020 when the FAC decided to defer the proposal if following recommendations-

- i. Since the proposal is not in conformity with the guidelines of Ministry dt. 20/05/2019 the State Government, if so desires, may approach Hon. Supreme court to seek the relief in this regard.
- ii. Comments of National Tiger Conservation Authority (NTCA) on the proposed proposal may also be obtained by the MoEF&CC for further consideration by the Committee.
- 2.0 In pursuance to the above said observations this office has submitted compliance as per reference 3, enclosing the detailed Note dated 12/08/2020 from the Chief Wildlife Warden. The concern expressed by the FAC is duly addressed to in the said Note of the Chief Wildlife Warden which is reproduced as under-
- b) In Maharashtra State the rehabilitation of 66 villages from the core area of tiger reserves has been done with the acquisition of 8613.63 ha of land vacated by these 66 villages and in lieu of this, only 2650.57 ha of forest land has been diverted for relocation so far. Thus, the land added to the core of tiger reserves as inviolate area and declared as Reserve Forests far exceeds the forest land diverted for rehabilitation in the State.

In addition to this, 15093 ha. of mangrove forests have been notified under section 4 of the Indian Forest Act, 1927 as Reserve Forests and 1774.84 ha. private land has also been declared as forests.

- c) The diversion of forest land in this proposal is for the purpose of conservation of tigers i.e. for making the core of tiger reserve as inviolate which is a top most priority of State Government as well as of Government of India. Furthermore, this is required to be done as per the provisions under section 38V of Wildlife (Protection) Act, 1972 as amended in 2006, which stipulates that the core area has to be kept inviolate. This activity is also financially supported by MoEF&CC so as to make the core area inviolate (free from any disturbance) for the creation of an ideal tiger habitat.
- 3.0 It may therefore be appreciated that if the scenario is considered in its entirety, as many as 66 villages from the core areas of tiger reserves have been rehabilitated adding up about 8613 has inviolate area at the expense of only 2650 has degraded forest land which has been diverted for the

- 4.0 It may further be appreciated that the very objective of the rehabilitation of villages from the core area, thereby eliminating the human interference from such inviolate area can be achieved only when the concerned village is relocated at one go. The phase-wise shifting of any village can never be expected to fetch the desired results for the obvious reasons.
- 4.0 The Note dated 12/08/2020 enclosed with the reference under 3 is self-explanatory and therefore considering the objective of the proposal it may be placed again before the FAC for its kind consideration.

Government of India has accorded in-principal approval for the subject proposal, under section 2 (ii) of the Forest (Conservation) Act, 1980, subject to the fulfillment of the conditions mentioned in the letter under reference dated 26/11/2019. Chief Conservator of Forests (T) Kolhapur vide letter dated 18/03/2020 has submitted the compliance of the conditions, which is furnished as under :-

Government of Maharashtra has requested GoI to extend general approval u/s 2 of the Forest (Conservation) Act, 1980 for laying of aerial OFC and erection of poles for this purpose vide letter under reference No.1 (Copy Attached)

- 2. The above request was discussed and deliberated before the Forest Advisory Committee (FAC) in its meeting held on 27.06.2019, when it sought following information:-
 - Detail proposal highlighting the dimension of poles, distance between poles, and height of poles and sagging of cables, in case the OFC is laid over ground within ROW of existing roads.
 - Comparative statement of financial implications of laying OFC over ground and underground.
 - Other considerations which State Government may deem fit to bring to the knowledge of FAC.
